- 1 a). I expect to reap immense benefits by studying a Masters Degree in Public Health. One of the areas in which I intend to benefit is my nursing practice. A master's program will increase my knowledge in the nursing practice and thus enhance my ability to diagnose the root of a patient's problem, including being able to make the connection between a patient and other social factors. For instance, I read a medical journal where a public health student gives an account of how he spent several days of his internship watching a homeless diabetes patient in a coma being treated with a view of optimizing his insulin regiment. The health workers in charge were mainly concerned with his medication. However, as far as the author of the journal is concerned, the patient's coma had little to do with medication issues. Rather, it resulted from social factors. With a long history of IV drug abuse, anxiety and depression, the patient lived in the streets while continually taking his insulin. He was definitely aware of the importance of taking his insulin and controlling his condition, but homelessness prevented him. Reading the story made me realize that I needed more knowledge in public health especially in relation to social determinants of health so as to be able to build such a connection. I can then be able to provide advice in situations such as the one described above for the patient to be provided with housing and hence be able to observe proper storage of insulin.
- b). Studying a Masters in Public health will be a key stepping stone to doing my doctorate, hence facilitating my progress towards a leadership position where I can be able to influence things in a wider scope. I have always been passionate about leadership and taking responsibilities, and I believe, a master's degree is indispensable towards achieving this objective. Many health workers ignore the fact that income, zip code, race, and ethnicity can sometimes be used to predict the health status of a person just as one's diet or family medical history. Pursuing a master's degree will help me to advice not only patients but also other health workers on social factors that may be the cause of certain health issues. Moreover, gaining more knowledge on environmental health issues will put me in a better position to advice my community on how to maintain a healthy environment. In so doing, health issues that result from environmental factors such as malaria can be prevented.
